Option #1 - \$15 per person

Option #3 - \$5 per person

- Recognition of your group's presence over the loud speaker.
- A finalized number of guests will need to be provided by and paid for no later than 1 week prior to event.
- There is no minimum ticket purchase requirement for Option #2.
